## INTRODUCTION TO THE LEAGUE: Finance

**Where Do My Dues Go?** Like most national organizations, the bulk of your dues are sent along up the ladder—in our case to the LWV of the Bay Area (LWVBA), the LWV of California (LWVC), and the LWV of the United States (LWVUS). The last time we had to raise the dues and also charge for a printed copy of *The Voter* was because we were actually losing money on membership.

Here's an example: Susan Member pays her \$65 dues to the LWVDV: \$30 goes to LWVUS, \$23 to LWVC, and \$1 to LWVBA, for a total of \$54. That leaves the LWVDV with \$11...not much money. Our major sources of income are from donations, the Contra Costa County contract for providing voter registration forms throughout the county, and rent paid by Lafayette Moraga Youth Activity so our portion of the rent is less.

**Our Bank Accounts:** LWVDV has two accounts:

- Our **Ed Fund** account is designated by the IRS as a 501(c)(3), so donations to that account are tax deductible. The checks made out to LWVC-EF are sent directly to Sacramento to what I like to call our savings account. This account is restricted; we have to apply to have our funds released back to us, and the LWVC-EF charges us a fee for managing the account.
- The other account is our **checking** account. Checks made out to LWVDV for dues or donations go into this account. This unrestricted account is what pays the bills: rent, phone, the *Voter*—all the regular operating and program costs. Donations made to this account are not tax deductible because this is designated a 501(c)(4) account. In the future this may change because our chapter doesn't actually do lobbying. Dues have to be made out to the LWVDV because we have to make payments from the checking account for LWVBA, LWVC, and LWVUS per member payments.

Donations are welcome to either account. The advantage of the Ed Fund account is that your donation is tax deductible. The advantage of donations to the LWVDV is that we can easily pay the bills and conduct programs. If you [donate online](#), you can use Pay Pal to make a donation to either account, and you don't have to have a Pay Pal account.

**Leaving a Legacy.** Including the LWV of Diablo Valley or the LWV of Diablo Valley Education Fund in your will is among the easiest ways to offer support of our work for years to come. If you already have a will, you can have your attorney add a codicil to include our League. Please use the following language to include the League as a beneficiary of a will or trust:

"I give, devise, and bequeath to the {League of Women Voters of Diablo Valley} {League of Women Voters of Diablo Valley Education Fund}, a charitable organization, with offices at 500 St. Mary's Road, #14, Lafayette, CA 94549, {the sum of \$\_\_\_\_ } {\_\_\_\_ percentage of my residuary estate}."

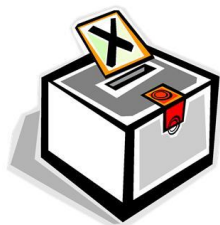

## **LEAGUE SPONSORS WELL-ATTENDED CANDIDATES' NIGHT FOR SAN RAMON CITY COUNCIL AND MAYORAL RACES**

On October 6, LWVDV co-sponsored a well-attended candidates' night at the San Ramon Community Center. Three candidates for two city council positions answered voters' questions for an hour, followed by an hour with the two candidates for San Ramon mayor. Unlike most Contra Costa cities, which rotate the mayor's position among city council members, San Ramon has a separately elected mayor.

Candidates for City Council are Scott Perkins, incumbent; Phil O'Loane, challenger; and Abram Wilson, who is currently the San Ramon mayor but is not allowed to seek the mayor's office again due to term limits. These candidates answered questions on Measure W, a failed ballot measure in San Ramon involving development of the Tassajara Valley; public comment time at city council meetings; the timing of San Ramon city elections; city budgets; and other city issues. Candidates for San Ramon mayor are Carol Rowley and Bill Clarkson. They received similar questions on city finances, sustainability initiatives by the city, growth management, and the stalled City Center project.

Co-sponsors of the debate with the League were the San Ramon American Association of University Women, Dublin-San Ramon Women's Club, and San Ramon Chamber of Commerce. Thanks to Lee Lawrence, Jeanne Melaugh, Sally Germain, and Nancy Vandell from the League who attended and volunteered at the candidates' night. I served as moderator.

The League's list of moderators has dwindled over the years, and we need to train a new crop of volunteers. I have found it to be a very useful skill to have, and I would highly recommend that if you are at all interested that you attend training. I would be willing to train new moderators to moderate candidates' nights sponsored by the League. ## **CELEBRATING 100 YEARS OF WOMEN'S RIGHT TO VOTE IN CA**

Our big event was our October 15 Celebration of 100 Years of Women's Right to Vote in California, which was also a chance to meet our elected officials. We shared food and wine, singing, making signs, and a march around the church grounds in honor of our suffragist foremothers. Assemblymember Joan Buchanan and Danville Town Council member Newell Arnerich attended, each honoring the League of Women Voters for its voter service, moderation of candidate debates, and clear recommendations about ballot measures. Arnerich was also the architect who designed the new Bortin Fellowship Hall at the Mt. Diablo Unitarian Universalist Church where the event was held. Staff from Senator Mark deSaulnier's office and from Assemblymember Susan Bonilla's office attended the event. We also heard from Carlyn Obringer, chair of the Contra Costa Women's Commission, and Reverend Leslie Takahashi-Morris.

It was very moving to see past League presidents: Alice Johnson, Joan Lautenberger, Martha Goralka, Gwen Watson, and Ashley Coates were in attendance. A tip of the hat to Martha Goralka, who had arranged for Beverly Lane and two re-enactors to engage us in the history of suffrage in California. They did an excellent job of bringing to life the struggle for voting rights.

The referendum passed October 10, 1911, by 3500 votes statewide (a margin of 1 vote per precinct) and by 22 votes in Contra Costa County. Our Vice President, Jeanne Melaugh, had copies made of portraits of suffragists Elizabeth Cady Stanton, Susan B. Anthony, and Carrie Chapman Catt with brief biographies for display. These were so impressive that Beverly Lane asked to borrow them to display at the Contra Costa Historical Society in Martinez until November 18. Finally we discussed the impact of women's votes, which are key supports for Social Security, Medicare, maternal health and early childhood education programs, and consumer protection legislation, including the Food and Drug Administration.
